The Teamsters Local 142 Training and Apprenticeship Trust Fund (“Fund”) is hiring an Assistant Certified Trainer. The chosen candidate will report directly to, and learn from, the current Certified Trainer/Training Coordinator, and will assume the role of Certified Trainer/Training Coordinator in May 2027. All qualified candidates will be considered; however, preference will be given to Teamsters in good status with their Local and the International.

Required Qualifications:

- Valid CDL with the following endorsements, all of which must be held for a minimum of two years prior to May 2027:
 - Class (A)
 - Passenger (P)
 - Tank Vehicle (N)
 - Double/Triple Trailers (T)
 - Hazardous Materials (H)
- No automatic transmission restriction on the CDL
- Current DOT medical card
- Ability to pass and maintain compliance with employer drug and alcohol testing requirements
- No current CDL suspension, revocation, cancellation, or federal disqualification under 49 CFR 383.51
- Must possess and maintain a safe, insurable, and compliant driving record, including compliance with all applicable DOT, BMV, and FMCSA safety standards
- Completion of the following prior to May 2027:
 - 51 semester credit hours at a postsecondary educational institution, and nine hours of driver education training that included theoretical and behind-the-wheel training OR
 - Completion of a BMV-approved instructor training program and 20 hours of behind-the-wheel training instruction.

At least one of the following is HIGHLY DESIRED:

- OSHA #510 completion, and five years of safety and health work experience in the construction industry
- OSHA #510 completion, and three years of construction safety experience, and a degree in occupational safety and health
- OSHA #510 completion, and three years of construction safety experience, and a Certified Safety Professional (CSP) designation
- OSHA #510 completion, and three years of construction safety experience, and a Certified Industrial Hygienist (CIH) designation

Other Qualifications:

- Strong knowledge of DOT/FMCSA regulations, pre-trip inspection standards, safe driving practices, and driver compliance responsibilities
- Ability to maintain a safe, professional, and insurable driving record
- Ability to obtain and maintain a TWIC card
- Experience instructing entry-level CDL students in classroom (theory) and behind-the-wheel settings
- Experience transporting bulk liquids, hazardous materials, and/or cargo tank loads
- Strong written and verbal communication skills
- Excellent organizational abilities
- Ability to fairly and accurately evaluate entry-level drivers

Job duties of the Certified Trainer/Training Coordinator include, but are not limited to:

- Teaching Construction Driver apprentices in both classroom (theory) and behind-the-wheel instruction
- Performing apprentice evaluations
- Observing apprentices at worksites
- Coordinating with Business Agents in rotating apprentices among employers to ensure that all apprentices receive on-the-job training in all facets of the Construction Driver trade
- Creating, updating, and implementing curriculum requirements for all non-on-the-job training
- Attending all quarterly Board of Trustees meetings
- Promoting the Apprenticeship Program through trade shows, career days, and community events
- Other duties as assigned by the Board of Trustees
